

1. **The Promoter**

The promoter is: Kickback Motorbike Show

2. **The competition**

1. The title of the competition is Kickback NWT Cycletronic
2. The Competition will be operated through Instagram. Please follow instructions as to how to enter below

3. **How to enter**

1. The competition will run from Tuesday 26<sup>th</sup> July 2022 and will close at midnight on 8<sup>th</sup> August 2022. (the "Closing Date") inclusive.
2. You must complete the actions on Instagram noted below before the Closing Date. All competition entries/posts received after the Closing Date will not be entered into the draw.
3. To enter the Competition:
  - (a) tag a friend in the comments of the competition asset posted on the @kickback.motorbike.show Instagram account and
  - (b) Follow @kickback.motorbike.show on Instagram.
4. No purchase necessary.
5.
